Trust Governance

TECT and TECT Charitable Trust operate under Deeds of Trust respectively dated 21 December 1993 and 27 March 2002. Provisions of the Electricity Amendment Act 2001 also impact upon Trust Governance.

TECT is governed by six trustees who are elected by beneficiaries for four-year terms. The terms of appointment of trustees are staggered so that three trustees retire every two years. The current trustees are Bill Holland (Chairperson), Natalie Bridges (Deputy Chairperson), Mark Arundel, Peter Farmer, Peter Blackwell and Tina Jennen. Trustees are responsible for managing TECT's assets for the benefit of qualifying beneficiaries.

Chairperson and General Manager's Report



Chairperson and General Manager's Report

The 12 months under review have provided much to think about for the trustees and the Trust as a whole. The global pandemic has been unprecedented in terms of its impact on health, wellbeing, and the economy, and has forced a rethink of how we all go about our business.

As the nation got on top of the pandemic, any hope for business as usual to be restored at TECT was once again disturbed in January 2021, when Trustpower announced a strategic review of its retail business. This review was aimed at testing market interest in the sale of Trustpower's mass market retail business. A sale of Trustpower's Retail Business to a third party meant that, under the TECT Trust Deed, TECT's beneficiaries would no longer be the current local retail customers, and instead, the beneficiaries after a sale would be only a small number of larger commercial and industrial electricity users in the Tauranga and Western Bay of Plenty region who would remain customers of the Trustpower generation business if the retail business was sold. Clearly the trustees had to act and later in this report we provide a summary of the activity that occurred.

Response to Covid-19

The Trust responded to the issues of Covid-19 in several ways. The office was able to implement business continuity plans which ensured TECT was able to operate throughout the entire 12 months including the lockdown period. In an effort to support the Trust's beneficiaries, the trustees made a decision to make an earlier payment of the mid-year rebate which was well received. Likewise, the Trust worked at speed to establish a collaborative funding approach with the BayTrust, Acorn Foundation and Tauranga City Council to ensure funds were available to meet the immediate and mid-term needs from Covid. The Covid-19 Rapid Response and Recovery funds were a great example of a community pulling together and working together.

Sale of Trustpower Retail

Trustpower announced on 28 January 2021, that it was undertaking a strategic review of its retail business, that included a potential sale. As a result, trustees released a proposal that outlined the changes to TECT's structure needed to meet the purpose of the Trust Deed, and to ensure that the best interests of the Trust and its beneficiaries were protected. The proposal protected the rebate for existing TECT beneficiaries for approximately 30 years. After a comprehensive consultation process, where 791 written submissions were received, trustees adopted a final proposal for changes to the Trust.

Approximately two-thirds of submissions received were supportive of the changes in the proposal and its focus on protecting the rebate, which is very encouraging and has given us the confidence to proceed to the next stage in the process.

As a result of these deliberations, trustees were satisfied that the proposal that was consulted on was the best solution to take forward. On 14 May 2021, the trustees filed an application in the High Court seeking orders under the Trusts Act 2019 that it is lawful and proper for the trustees to implement the proposed changes to TECT. The court hearing for that application will take place later in the year.

A subsequent announcement was made by Trustpower on 21 June 2021 that it had agreed a conditional sale of its gas, telecommunications, and retail electricity supply business to Mercury NZ Limited for \$441 million.

The confirmation of the conditional sale of Trustpower's retail business reaffirms how crucial it was for us to act when we did to ensure that the rebate was protected for our existing beneficiaries under a change of ownership.

Trustees will now need to carefully consider the specific detail of the conditional sale, prior to shareholder approval in September. We note that the majority shareholder Infratil has advised it intends to vote in favour of the sale.

Finance & Investment

The financial year was dogged by the coronavirus-triggered market volatility. Global share markets bounced back spectacularly from the brief Covid-induced shock early last year that saw indices rapidly fall as much as 30% in March 2020. Approximately 60% of TECT's assets are held through a 26.8% shareholding in Trustpower. The remainder is made up of a diversified portfolio of investments including a range of national and international investments. Together the Trust fund was valued at \$1.14B at 31 March 2021. The Trust continued to be supported by investment advisor Fidato Ltd, which provided strategic advice to assist the trustees in developing their investment policies and to help evaluate the performance of the Diversification Portfolio and the Trust's investment managers.

The key financial results for the year are as follows:

- Group profit before tax was \$32.5M. This compares to \$52.6M in the previous year (which included a special dividend from Trustpower).
- Group expenses were \$2.9M compared to \$1.6M in the previous year reflecting the additional costs of related to the restructure, as well as the Trustee election, and additional costs related to the Covid-19 situation.
- Group equity grew by \$267M to \$1,137M.
- The diversified portfolio returned 38.4% driven largely by the bounceback from the market volatility in March 2020.

Distributions & Grantmaking

It was pleasing to be able to react to the turmoil of Covid-19, and provide support where it was most needed. For the TECT rebate this meant bringing forward a payment to allow an early payment in May which was well received by the Trust beneficiaries. The Trust also worked at speed to establish a collaborative funding approach with other local funders. From this fund, \$924,000 was distributed to 66 community groups in 2020/21, with TECT contributing \$411,916. It was humbling to see the innovation and community spirit that those within our community displayed to address the need.

Alongside the rebate, TECT's grants programme continued to contribute to the creation of a region from which not only current residents will benefit, but future generations. This intergenerational impact continues to be seen and measured throughout our community. This community support reaches from grassroots causes that would otherwise find it hard to qualify for funding elsewhere, through to transformational projects that equally need TECT to get off the ground.

It is always inspiring to see the amount of commitment and passion from those that work in the community sector, and we thank all the wonderful community groups for their ongoing work.

The key distribution highlights for the year are as follows:

- The Trust received 299 applications and approved 257.
- A total of \$7.4M was approved for distribution across TECT's five grant funds.
- \$30.9M was distributed to beneficiaries via three rebate payments.



Governance & Management

The biennial election of trustees took place in mid-2020 with 13 nominations received. The election saw the retirement of Amanda Sutcliffe and we all thank Amanda for her contribution. Bill Holland and Natalie Bridges were re-elected and were joined by Peter Farmer as the three elected trustees.

The year under review and the following 2021/22 will no doubt be viewed in future years as one of the most significant periods for the Trust. The trustees have had to navigate their way through a number of significant challenges and their commitment can be shown through the number of meetings held throughout the year as they worked to ensure the Trust is future-proofed in the ever-evolving world we live in.

The small TECT management team responded professionally and at pace to the demands of Covid-19, as well as the work required in regard to the restructure. This was no normal year, and the team can be proud of what they have achieved in an extremely challenging financial year. We were also supported by a number of advisors who continue to provide specialist support when required – we thank them for their service.

It is a privilege to work for the Trust and we all look forward to continuing to make a positive impact upon this region.

Our Collaborative Response to Covid-19

In the wake of Covid-19, it was clear we had an important role to play in supporting our community - not only in its survival, but in its recovery. But just like our country working together to stop the spread of Covid-19, we knew that working together with other local funders would amplify our impact.

TECT, BayTrust, Acorn Foundation and Tauranga City Council's Community Services Team met and quickly agreed that a joint funding approach with a single application and pool of funds would be the quickest way to meet the immediate needs of community groups heading into lockdown. TECT offered to play the lead role and other funders supported the process design.

Rapid Response Fund

The four funders committed to a combined pool of \$600,000 from their granting reserves to support community groups experiencing increased demand and/or funding shortfall as a result of the initial Covid-19 lockdown.

Groups who were providing essential services as defined by the government were invited to make the first applications before it was opened up to the wider not-for-profit sector. Others eligible to apply included groups that faced a significant funding shortfall, saw an increase in demand or faced additional costs in enabling them to adapt their service delivery to meet the restrictions of the government's Alert Level system.

The Rapid Response funding was over and above annual operating and programme funding support provided by the individual funders.

We were committed to working together to get the funding where it was needed most, paying grants quickly and upfront, and adapting to evolving community needs in order to support gaps not covered by government funding. It was also the first time funders' boards delegated decision-making to CEOs and GMs to ensure timely responses to requests.

Over an 8-week period, we were able to support 34 community groups. From IT purchases and PPE, to community meals and food parcels, \$231,500 in funding went a long way to helping community groups protect and care for the most vulnerable in our community. TECT's contribution to this totalled \$95,000.

WBOP COVID-19 Recovery Fund

In June 2020, after the lockdown period had ended, the funders decided to transition to phase two of their Covid-19 response.

The fund was made up of residual funds from the Rapid Response Fund, and an additional \$400,000 of contributions by all funders. The Recovery Fund opened in June with \$772,000 available.

While the initial Rapid Response Fund launched by the funders in April provided emergency support, the WBOP COVID-19 Recovery Fund aimed to aid the recovery phase; enabling the longer-term rebuild of the community sector.

The fund supported groups providing immediate or essential services such as food banks, refuges, and emergency housing, and those organisations working to prevent an escalated need for emergency support such as budgeting, alcohol and drug services, family violence prevention, and housing advocacy.

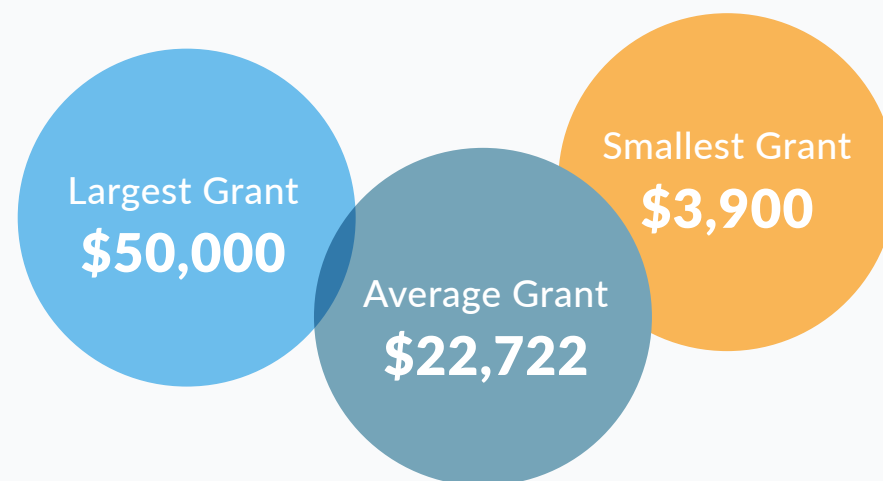
Those organisations responding to economic and social issues were also supported, including community-led engagement programmes, inclusivity initiatives, cultural opportunities, and youth engagement programmes. These groups all reported a spike in client anxiety from school closures, job losses, and vicarious fear of Covid-19.

Community groups that applied for funding were typically facing either increased demand or income shortfall due to Covid-19. In total, over \$770,000 was granted out of the Recovery Fund, with TECT contributing \$345,000 of that. We were delighted our collaborative funding effort could help over 30 community groups continue their service delivery, improve their capability to deliver and ensure they would meet financial commitments.

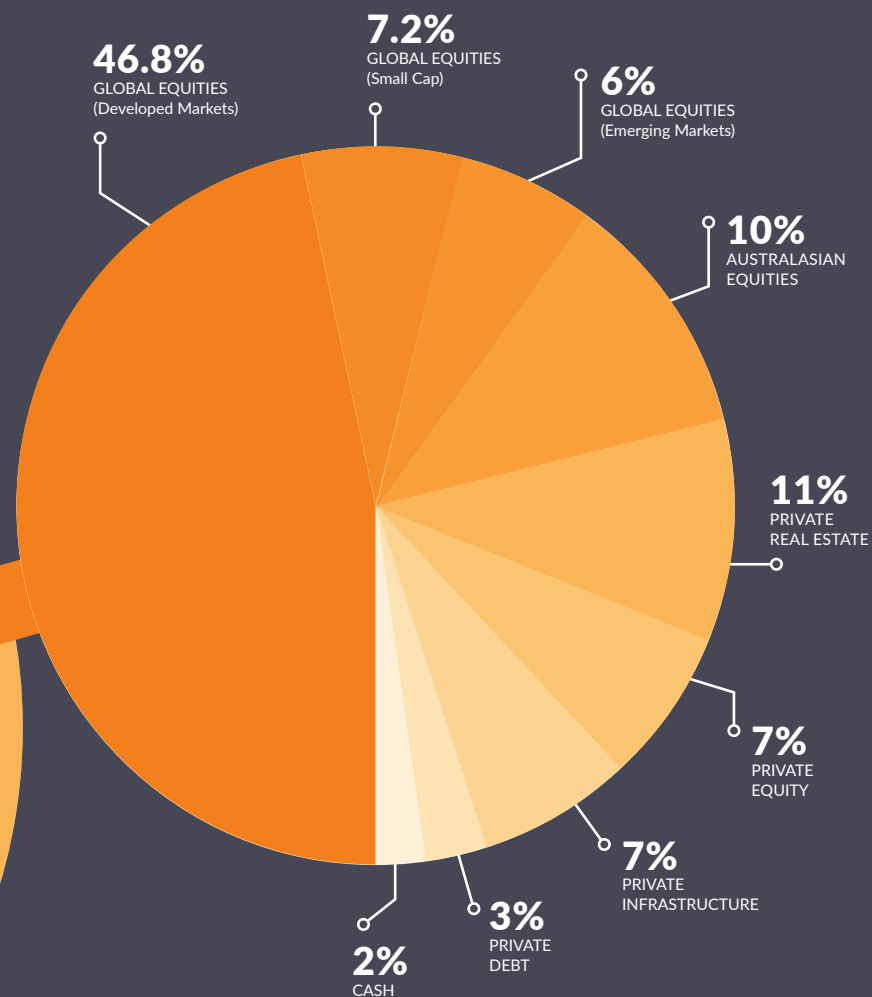
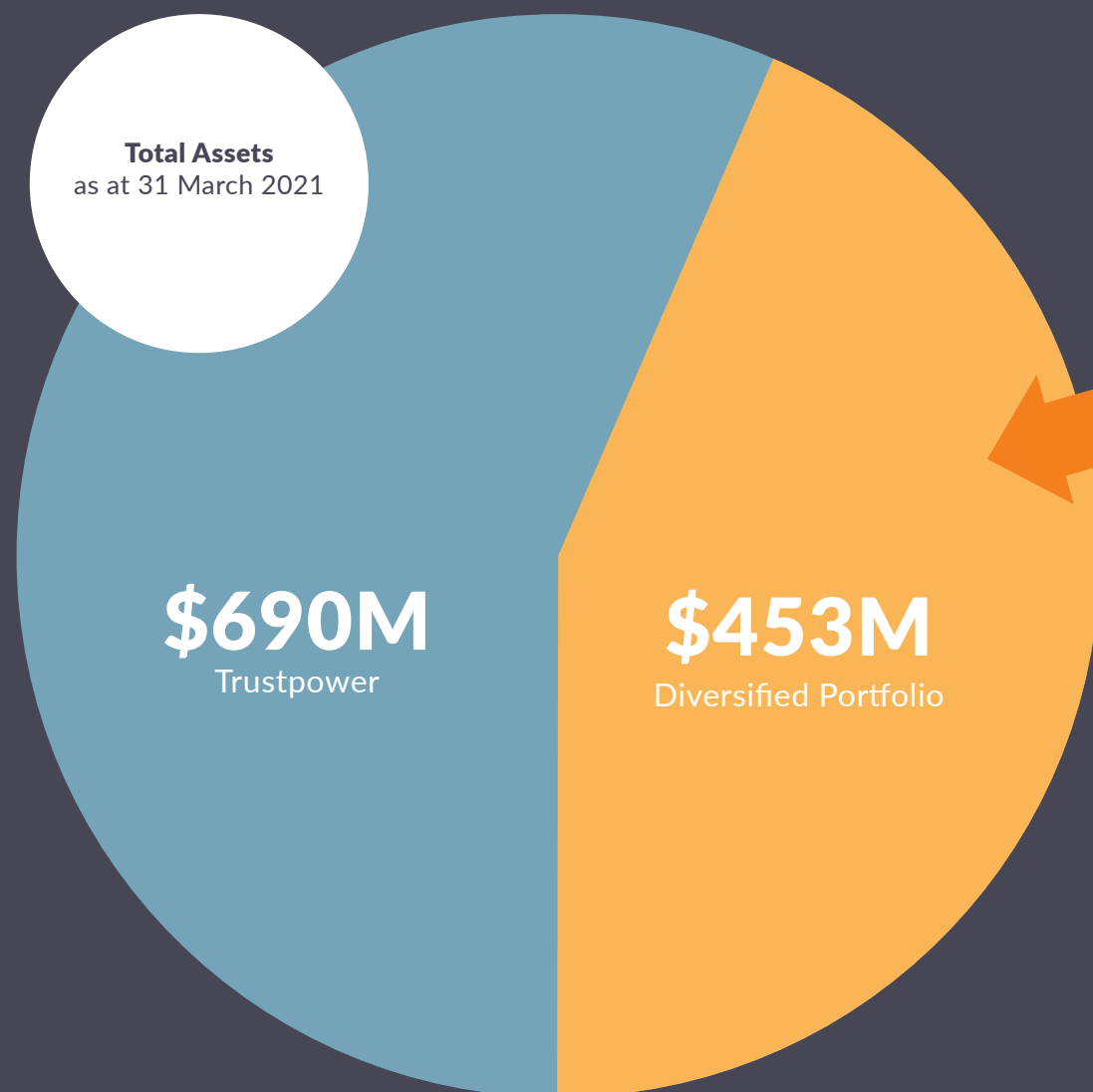
Feedback from community groups

TECT Proposal 2021

On the 28th January 2021, Trustpower announced that it was undertaking a strategic review of its retail business, including a potential sale.

A sale of Trustpower's retail business to a third party would mean that TECT beneficiaries would no longer be Trustpower's 53,000 Tauranga and Western Bay local retail customers. Instead, TECT's beneficiaries would only be a small number of larger commercial electricity users that remain customers of the Trustpower Generation business.

Trustees released a proposal on the 18th February 2021 that outlined the changes to TECT's structure needed to meet the purpose of the Trust Deed, and to ensure that the best interests of the Trust and its beneficiaries were protected.

The proposal that was consulted on balanced the protection of the annual TECT rebate for existing beneficiaries, and the purpose TECT was established for.

791 written submissions were received during the consultation period, and 32 of these were heard during the oral hearing that took place on 25 March 2021.

Trustees reviewed all feedback and adopted a final proposal for changes to the Trust, as outlined below. Approximately two-thirds of submissions were supportive of the changes in the proposal and the focus on protecting the rebate.

Thank you to all who engaged with the process and provided views through a written submission, attendance at one of our consumer information sessions or at the oral hearing.

Trustees are confident that the final proposal will ensure that TECT will continue to meet the purpose it was established for while future-proofing the rebate.



How is TECT is changing?

TECT would retain funds which are sufficient to pay a yearly rebate to all existing beneficiaries (as of Thursday 28 January 2021) for approximately 30 years (i.e. the intention is to retain enough funds to pay, based on current financial projections, rebates until 31 December 2050).

An existing beneficiary is essentially a customer of Trustpower in the defined Tauranga and Western Bay of Plenty District who currently is eligible to receive a rebate.

The changes will be implemented by changing the TECT Trust Deed as summarised in the Consumer Information Memorandum dated 18 February 2021, such as changes to the definition of Consumer, the distribution clauses to lock in the rebates, the removal of the restrictions on selling Trustpower shares, the provisions regarding trustees and the provisions about winding up.

The balance of TECT's funds (including its shareholding in Trustpower) would be transferred to a new long-term community trust focused on grants for local community projects.

What now?

As a final step, TECT made an application to the High Court on 14 May 2021 for directions confirming the validity of the trustees decision. That application is yet to go to a hearing. The proposed restructure will only proceed if the High Court makes those directions. More details about the court proceeding can be found on the Trust's website, www.tect.org.nz.



TECT COMMUNITY AWARDS 2021

Key Projects



Te Tai Whanake ki Tauranga Moana

A Te Ao Māori Localised Curriculum is being developed for all 67 Tauranga Moana schools, early childhood centres and the wider community in partnership with Tauranga Moana Iwi thanks to a TECT grant of \$176,640. The Curriculum will encompass foundational Te Reo, our Tikanga, stories and history; a tremendous resource for all educational organisations in Tauranga Moana, while also benefiting the wider community by being accessible to all.



Tauranga Riding for the Disabled

TECT has supported the Tauranga RDA since 1996, and this year approved funding of \$140,000 over two years towards their operating costs. The funding provides much-needed assurance the charity can continue their equine-based therapy programmes in the years ahead. It was another cause for celebration after the charity completed its building extensions and all-weather riding arena in 2020 thanks to a \$200,000 TECT grant.



20 Degrees

20 Degrees is a collaborative healthy housing programme dedicated to helping our community work towards warmer, drier and healthier homes that can reach 20°C cost effectively. The programme is backed by one of the largest collaborative funding efforts in our region's history. TECT and five other funding partners committed over \$1.5 million to the first three years of the programme's rollout.

Key Projects



Kopurererua Valley Floating Walkway

The Kopurererua Valley Rotary Centennial Trust works to assist with the 'K' Valley reserve development - enhancing the enjoyment of the area by the community for recreational purposes. The Trust sought TECT funding of \$141,800 to develop a floating walkway that would have minimal impact on any archaeological features below. As a significant historic site where the wounded were taken following the Battle of Gate Pa, and a fantastic recreational reserve, we were delighted to support the project.



Papamoa Surf Lifesaving Club

The new Papamoa Surf Lifesaving Club is a building that represents a lot for the future. Lives that will be saved, sporting careers that will be developed, and memorable events that will be hosted. Future-proofed for tomorrow's needs, the new base features secure space for rescue equipment storage, education and training areas, improved communication systems, first aid facilities, and duality for broader community use. As a cornerstone funder, TECT contributed \$1 million towards the project - a significant community facility we're proud to be a part of.



TECT Rescue Helicopter

Since 2003, TECT has supported the TECT Rescue Helicopter with over \$2.6 million in funding to help cover operating costs. \$600,000 of that was approved in 2019 to support the charity over the following three years. The TECT Rescue Helicopter performed 448 life-saving missions in 2020 - we are incredibly proud to support this vital community service.

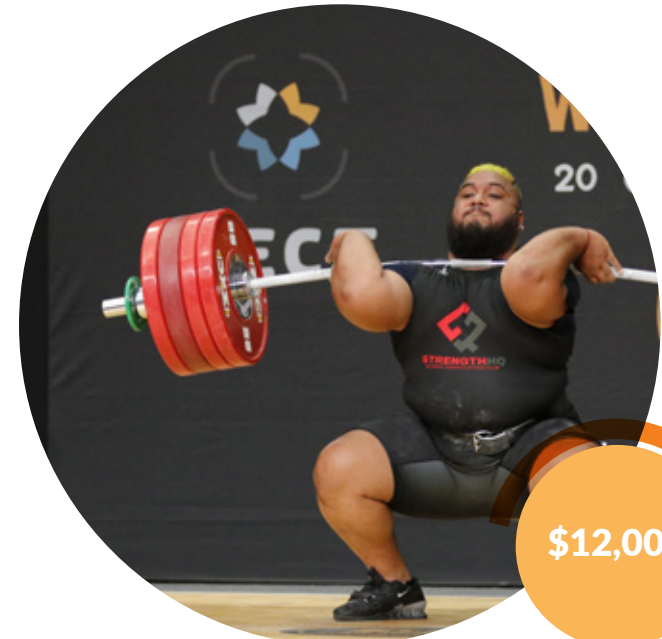

Notes

to the consolidated
financial statements

1. Reporting Entity

These are the Summarised Financial Statements for the TECT Group comprising Tauranga Energy Consumer Trust (TECT), TECT Charitable Trust, TECT Holdings Limited and TECT Property Limited.

The Tauranga Energy Consumer Trust was established under a Trust Deed on 21 December 1993 as a consequence of the Tauranga Electric Power Board's Establishment Plan. TECT is a Consumer Trust, the income and capital of which are to be used to provide benefits to Consumers who are Trustpower customers in the area defined in the Trust Deed (being the area supplied by the Tauranga Electric Power Board as at 21 December 1993 subsequently amended to include the Tauranga district area previously supplied by Tauranga Electricity Limited).

Tauranga Energy Consumer Trust is not a Charitable Trust and accordingly may not continue for more than 80 years. On the winding up of the Trust, all surplus assets shall be paid, applied or appropriated to or for the benefit of the consumers.

At 31 March 2021 TECT Group held 83,878,838 shares in Trustpower; representing 26.8% in the capital of the company. These shares are held by TECT Holdings Ltd, a 100% wholly owned subsidiary company.

2. Basis of Preparation

The summary financial statements are prepared in accordance with FRS 43 Summary Financial Statements. The full financial statements have been prepared in accordance with New Zealand Generally Accepted Accounting Practice (NZ GAAP), as applicable for profit-oriented entities. The Trust has made an explicit and unreserved statement of compliance with New Zealand Equivalents to International Financial Reporting Standards Reduced Disclosure Regime (IFRS RDR) in its full financial statements.

This summary is extracted from the full financial statements authorised for issue by the Trustees on 15 June 2021, for which an unmodified audit opinion has been given. This summary has also been examined by Crowe New Zealand Audit Partnership and a copy of their summary unmodified audit opinion is included in this report.

The summary financial statements are presented in New Zealand dollars and rounded to the nearest dollar.

The summary financial statements cannot be expected to provide as complete an understanding as provided by the full financial statements of the Trust. 3. Taxation

The tax expense of \$2,553,752 relates to the deferred tax effect of the current year profit and reduction in excess imputation credits. (2020: benefit of \$1,845,167 relates to the tax effect of the current year losses, excess imputation credits not recognised).

4. Trustpower Limited Investment

TECT Group has the majority of its funds invested in Trustpower. The share price in Trustpower is subject to significant fluctuations. In the two months immediately following balance date the Trustpower price varied between a low of \$6.50 and a high of \$8.70 compared to a market price of \$8.23 at balance date.

6. Related Party Transactions

Bill Holland, Wayne Werder and Mark Arundel are trustees of the Tauranga Tertiary Campus Charitable Trust. There were no transactions between TECT and the Tauranga Tertiary Campus Charitable Trust for the 2021 year. (2020: NIL)

Peter Farmer is a director of Farmer Motor Group Limited. During the 2021 year, TECT paid monies to Farmer Motor Group Limited for services in relation to motor vehicles. All services provided were on normal trade terms.

Trustees are required to be Consumers as defined in TECT's Trust Deed and are therefore beneficiaries of TECT and accordingly are related parties. All transactions with related parties are undertaken in the normal course of business on normal commercial terms.

7. Subsequent Events

On the 28th of January 2021, Trustpower announced it was undertaking a strategic review of its retail business, including a potential sale.

As Tauranga Energy Consumer Trust is a 26.8% shareholder of Trustpower, the sale of its retail business would also require changes to the structure of Tauranga Energy Consumer Trust.

After a comprehensive consultation process including a notice of proposal for beneficiaries to make submissions, Trustees have reviewed all feedback and have adopted a final proposal for changes to the Tauranga Energy Consumer Trust.

As at 31 March 2021, the Trustees were continuing to work with engaged advisors to assist with the implementation and next steps.

On 14 May 2021, the Trustees filed an application in the High Court seeking orders under the Trusts Act 2019 that it is lawful and proper for the Trustees to implement the proposed changes to TECT.
