Dear Consumers

I am pleased to report that TECT finished the year ended the 31st March 2013 in good shape. Shortly after year end however, some politicians raised the spectre of political interference in NZ's electricity market and this could have negative consequences for TECT and its Consumers.



TrustPower

TECT was established to hold shares in TrustPower and to distribute the dividends from that shareholding for the benefit of Consumers. TECT's major investment remains a 33% shareholding in TrustPower. In the year under review TECT received dividends from TrustPower of \$41.5 million, the same as last year's payout of 40 cents per share. The value of the TrustPower investment at 31st March 2013 was \$7.70 per share compared to \$7.25 as at 31st March 2012.

In a period of flat demand, TrustPower has shown an ability to operate successfully in a very competitive environment. Projects involving the development of a second stage of TrustPower's wind farm in South Australia, irrigation opportunities in Canterbury, the provision of telecommunication services and gas reticulation have resulted in TrustPower moving to become a multi product service provider with diversified income streams.

Electricity Reforms

It is disappointing therefore to report that reforms to the electricity market proposed by some politicians at the beginning of April this year could significantly impact the value of TECT's shares in TrustPower and TECT's income from this investment. The proposal involves the compulsory acquisition of electricity by a state agency. The supply of electricity by a state monopoly has not proved successful in the past and the compulsory acquisition of electricity at prices set by the state monopoly is a concept which could have wide-ranging implications for business generally in New Zealand. Consumers should analyse such proposals very carefully.

Consumer Consultation

Trustees formally review the ownership of TECT's shareholding in TrustPower at 5 yearly intervals. This review involves consultation with Consumers. Trustees are currently undertaking an ownership review which is the fourth such review Trustees have undertaken since TECT was

formed. Notwithstanding the possible political interference mentioned above and the potential for future demand to be affected by the closure of the Tiwai Point Smelter, Trustees consider that the retention of TECT's investment in TrustPower remains consistent with its Deed and still represents value for Consumers. Trustees propose that the core investment of 26.36% of TrustPower be retained subject to continued monitoring and that Trustees retain their right to sell down to that level without further consultation. In view of the heightened risk of political intervention and questions about the future demand for electricity, Trustees do encourage Consumers to provide their view on continued ownership of TECT's shareholding in TrustPower. Submissions on the ownership review will close on the 31st August 2013. Further details of the Share Ownership Review are available on TECT's website.

Key Financial Results for the year are as follows

- Group equity increased by \$54 million, an increase of 7.5%.
- Short term money market deposits of \$10.8 million were committed to TECT's funding reserves and distribution provisions.
- Group profit was \$38.9 million compared to \$39.1 million in 2012, a decrease of 0.6%.
- Group expenses decreased by \$560,000, (14.9%). This decrease is attributable to reduced interest costs as a result of reduced debt.
- Debt was reduced by \$15.5 million during the year to \$27.5 million.

Distributions to TECT Consumers

This year \$32.6 million was allocated to TECT's Consumer distribution schemes. TECT's primary distribution scheme is its cheque distribution to Consumers and this year \$25.7 million was distributed, tax free, directly to Consumers through the annual cheque distribution scheme. TECT has now distributed over \$220 million direct to Consumers since 1994. The minimum amount distributed to Consumers has grown from \$20 per Consumer in 1994 to \$385 in 2012. I am pleased to announce that Trustees have resolved to further increase the minimum amount to \$400 per Consumer to be distributed in November 2013.

\$6.9 million was allocated to TECT's other Consumer Community Organisation Schemes for distribution. A significant grant made in 2011 to the Tauranga Hockey Association to enable it to upgrade its hockey turfs has now been put to good effect in the completion of a well utilised sporting facility which meets international hockey standards. A grant was made to the Bay of Plenty Clinical School for a range of simulation equipment for the school's skills lab. A grant of \$500,000 was made to the Order of St John to enable it to commence construction of a

new facility in Te Puke which will enable it to better meet the increasing demand for services in the Te Puke/Papamoa region.

Throughout the pages of this report, you will gain a glimpse of the exciting work taking place in Tauranga and the Western Bay of Plenty. We trust you will find the contents enlightening and encouraging.

Trustees

The biennial elections were completed in June 2012 and were hotly contested by 23 candidates for the three available positions. This shows the strong interest in our community in the activities of TECT. We thank each of the candidates for making themselves available for election. The election saw Bruce Cronin and Ken Collings returned as Trustees and the election of Bill Holland. The election of Bruce and Ken is a tribute to the fine work that they do on behalf of Consumers. Bill Holland has settled into his work and adds to the breadth of experience that current trustees have over a wide range of undertakings.

Strategic Review

Trustees are engaged in a strategic review of TECT's Consumer Community Organisation Distribution Schemes to determine whether those schemes can be better tailored to deliver increased benefits to Consumers and achieve TECT's vision that our Consumers live and are engaged in a vibrant and enriching community. The challenge is to understand and leverage the benefits to Consumers that each of our Consumer Community Organisations can make. Consumers will be advised of the progress of this review as it occurs.

Secretariat

Our secretary, Fraser Lellman, and his team of Char Niles, Jeanette Voss and Judi Priest have provided great service to Trustees and to Consumers during the year. We thank them for their efforts.

Conclusion

It is a privilege to report on this past year. I hope you enjoy reading the report and that you agree with me that TECT is an organisation worth celebrating for the contribution it makes to our community. We look forward to the future confident (if political interference can be denied) that TECT can play a greater role in benefiting Consumers.

TAURANGA HOCKEY STICKS IT WITH THE BEST

Worn stitching, cracked paint and patchy fix-it jobs on the turfs at Tauranga Hockey Association are things of the past thanks to an \$800,000 grant from TECT and significant backing from other funders and supporters. The two turf fields were well beyond their use-by dates. The paint was raised causing the ball to lift into the air making it dangerous to play, and the stitching was breaking down meaning there were gaps in the turf. There were patches on the turf that had been fixed but still deteriorating and the lighting was inadequate. For safety reasons and to protect the future of the sport, a major upgrade was required.

The purpose-built facility now boasts a pair of international quality water turfs to support the current and anticipated growth of hockey in the region. The facility is used up to eight hours a day, seven days a week especially for training sessions and local competition matches. Over 2,000 enthusiastic local hockey players of all ages now enjoy use of the new, safe turfs winter and summer, daylight 'til dark. There has been a huge surge in juniors with 85% of members being school-aged. The impressive transformation of the facilities ensures hockey will continue to thrive well into the future.

Tauranga and Western Bay of Plenty not only have a lively and growing sports culture, but the region also boasts some of the best sporting facilities in New Zealand. TECT is proud to contribute to major amenities such as Tauranga Hockey, Baywave, ASB Arena and the TECT All Terrain Park which all provide real benefits for our community.

CAPTURING THE MAGIC ON CANVAS

Katikati is once again hosting local, national and international artists in the fourth biennial NZ Mural & Arts Festival 2013 running from 1 to 6 October 2013. The whole town comes alive during festival week with children's art contests, ethnic dancing and food tasting, music, sculpture, street art and street theatre.

This year's theme 'Cultural Encounters' will certainly capture the imagination. Mural artists are invited to submit their interpretation of this theme and the top eight will be invited to compete with all murals painted in public locations around Katikati. The public will have front row seats to watch as the artists bring their creations to life. The quality of the art work being produced now makes this event a major forum for outdoor art in New Zealand, with an international flavour.

The Katikati Open Air Art project is a community based initiative designed to celebrate the unique identity and heritage of Katikati through murals that highlight specific historical, cultural and environmental influences. TECT approved a grant of \$5,000 to Katikati Open Air Art Inc to ensure the continued growth and success of this unique festival.

The 'mural town' as Katikati is affectionately known, is now established as a visitor's destination with over 50 murals and sculptures on public display.

SPCA Centres all across New Zealand have now embraced the Saving Lives philosophy. Every animal has the right to a chance, and the Tauranga SPCA is continuing to ensure that is the case for all animals in the region. The SPCA was offered the chance to expand the centre in Greerton through a generous bequest. Along with TECT's support of \$250,000 the centre has undertaken a major makeover including extensions and redeveloping the entire interior space to provide quarantine facilities, animal reception, ultra-violet scanning, cat checking facilities including electronic weighing, food and bulk storage areas, kitten nursery and nursing area.

The upgraded facility will now see the hundreds of animals that pass through the centre each year checked, quarantined, treated, fed and housed in more functional areas before finally being adopted into their new homes.

The Tauranga SPCA supplies essential services 24/7. The centre encourages the care of animals through its involvement in the community, they take animals into pre-schools, run animal care and welfare education for schools and host tours through the centre which are a fun and interactive way to learn about the SPCA. They also offer support and advice for treatments and behavioral problems for family pets.

Pets are members of our families; they are intelligent, caring, compassionate, loyal, forgiving, understanding and true companions. Just ask anyone who has a pet - they truly are friends worth having.

HEI MARAE REALISING A DREAM

The Waitaha people have a dream – that their mokopuna be healthy, educated, prosperous and aware of their heritage. Central to this vision is their Marae in Te Puke.

So the Hei Marae community set to work to make their dream a reality with a TECT grant of \$150,000. The old wharekai built in 1899 was pulled down. Sadly, all the native timber was riddled with borer making it impossible to reuse for the new building. On the landscape now stands a proud new wharekai named Ngataiwhakaki featuring a dining room, kitchen, chillers, storage, multi-purpose room/kaumatua lounge, laundry and full ablution facilities.

The new building is just one step along the path to re-energizing the Hei Marae community. The wharenui and carvings are also to be restored, new car parking areas established, landscaping and retaining walls built.

Hei Marae is integral to the surrounding community with school visits, hosting seasonal workers and providing a facility for community programmes and events. These improvements will see the Marae re-establishing itself as a central facility fully utilised by iwi and community members.

IMAGINE IT, CREATE IT, PLAY IT

Golden Sands School in Papamoa has moved away from the traditional forms of playground equipment, instead creating more natural play areas that encourage children to be more imaginative in their play. With an expected roll growth of 500 in the next few years, the school consulted heavily with the community and has designed an exciting 21st century learning environment. The buildings are designed for flexibility, collaborative learning and with tools that provide anywhere, anytime, any place learning.

The new play areas are intended to stimulate the senses leading to more diverse and creative playtimes yet still burning energy, helping build core body strength and developing balance. Research suggests that children are more attentive and focused after playing in a more natural and novel environment. Something as simple as sand, slopes and sleepers have been put together by the school to create a field of adventure for anyone with an imagination, while the more adventurous can climb, swing, slide or hang upside down on the climbing wall, gym rings and balance beams.

The outdoor musical garden adds the final touch. Not many schools can boast an outdoor music room with musical instruments designed and tuned to the pentatonic scale, allowing children to compose music while playing.

TECT's grant of \$42,303 ensures the new playground and musical garden provides students and families an option for all year imaginative play.

ST JOHN TE PUKE ON THE PULSE

When it comes to saving lives, it helps to at least have an ambulance station to house the vehicles and equipment! So when St John Te Puke was forced to move from the premises it had occupied for over 70 years, it was an ideal opportunity to find a site which would be better suited to its needs and TECT was keen to help.

With the area St John covers extending from Papamoa East to beyond the Matata Straight, a central location with easy access was of paramount importance. Having found and purchased a suitable property, completed building plans and arranged the necessary consents, the St John Te Puke team then set about raising the finance needed for a purpose built facility which would stand them in good stead for the next 50 years.

TECT was approached and approved \$500,000 towards the project. The new facility will include garaging for ambulance vehicles, kitchen, dining, recreation, bathroom, storage, office facilities equipment and rest areas for overnight accommodation.

St John provides emergency ambulance services for nearly 90% of New Zealand. The Te Puke branch attended over 1,700 callouts last year so there's no doubt being an emergency response worker is a hard job. Many will benefit from the new facilities – from the staff who work there every day; the St John Youth Unit which ensure the future of the organisation in the region and train in the building on a regular basis; the many groups and businesses who undertake first aid courses; and other community groups.

INDEPENDENT AUDITOR'S REPORT ON THE SUMMARY FINANCIAL STATEMENTS YEAR ENDED 31 MARCH 2013

1. REPORTING ENTITY

These are the Summarised Financial Statements for the TECT Group comprising Tauranga Energy Consumer Trust ("TECT"), TECT Charitable Trust, TECT Holdings Limited, TECT Finance Limited and TECT Finance No. 2 Limited.

The Tauranga Energy Consumer Trust was established under a Trust Deed on 21 December 1993 as a consequence of the Tauranga Electric Power Board's Establishment Plan. TECT is a Consumer Trust, the income and capital of which are to be used to provide benefits to Consumers who are TrustPower customers in the area defined in the Trust Deed (being the area supplied by the Tauranga Electric Power Board as at 21 December 1993 subsequently amended to include the Tauranga district area previously supplied by Tauranga Electricity Limited).

TECT is not a Charitable Trust and accordingly may not continue for more than 80 years. On the winding up of the Trust the assets of the Trust, which remain, will be distributed for the benefit of Consumers.

TECT Group holds 103,878,838 shares, representing 33% in the capital of TrustPower Limited.

2. BASIS OF PREPARATION

The summary financial statements are prepared in accordance with FRS 43 Summary Financial Statements. The full financial statements have been prepared in accordance with New Zealand Generally Accepted Accounting Practice (NZ GAAP), as applicable for profit-oriented entities. The Trust has made an explicit and unreserved statement of compliance with International Financial Reporting Standards (IFRS) in its full financial statements.

This summary is extracted from the full financial statements authorised for issue by the Trustees on 18 June 2013, for which an unqualified audit opinion has been given. This summary has also been examined by KPMG and a copy of their summary unqualified audit opinion is included in this report.

The summary financial statements are presented in New Zealand dollars and rounded to the nearest dollar.

The summary financial statements cannot be expected to provide as complete an understanding as provided by the full financial statements of the Trust. You can obtain a copy of the full financial statements free of charge from the TECT office at 96 Cameron Road, Tauranga 3141 or the Trust's website, www.tect.org.nz.

3. TAXATION

The tax expense of \$802,620 relates to current group tax charges of \$32,927,938 less dividend Imputation Tax Credits of \$31,081,276 and tax effect of tax losses of (\$1,044,042).

4. DEFERRED TAX

Deferred tax shown in the statement of financial position arises primarily from revaluation of financial instruments to fair value. During 2012 a re-estimation of the deferred tax liability arising in relation to the fair value movements in TrustPower shares was made, based around the level of imputation credits likely to be attached to future dividends. This resulted in a reduction in the deferred tax provided in the 2012 year. The level of imputation credits attached to dividends is now more certain but may still vary significantly from year to year. Accordingly the deferred tax calculation has been based on an average of the credits received during the last three years. The estimated level of imputation credits is reviewed at each reporting date.

5. IMPUTATION CREDITS

As TECT is not a company it does not have an Imputation Credit account. TECT Holdings Limited, TECT Finance Limited and TECT Finance No. 2 Limited are registered as an Imputation Group. As at 31 March 2013 the Group had Imputation Credits available of \$28,997,597 (2012: \$30,361,143).

6. TRUSTPOWER INVESTMENT

TECT Group has the majority of its funds invested in TrustPower shares. The share price is subject to significant fluctuations; in the two months immediately following balance date the price varied between a low of \$7.18 and a high of \$7.80 compared to a market price of \$7.70 at balance date.

7. COMMITMENTS AND CONTINGENCIES

TECT Trustees have agreed in principle to consider an application for funding from Tauranga City Council and Western BOP District Council for tsunami warning system. It is envisaged that this funding would come from the Major Amenities Fund and is unlikely to exceed \$1m. Other than this, there were no commitments or contingencies at the end of the financial year (2012: Nil).

8. RELATED PARTY TRANSACTIONS

Mr Michael Cooney is Chairperson of Tauranga Energy Consumer Trust and TECT Charitable Trust. He is a Director of TECT Holdings Ltd, TECT Finance Ltd and TECT Finance No. 2 Ltd and is also a director of TrustPower Ltd. Net dividends received by TECT Group from TrustPower Ltd during the year ended 31 March 2013 totalled \$41,551,535 (2012: \$41,551,535). At 31 March 2013 the TECT Group shareholding in TrustPower Ltd was 103,878,838 shares valued at \$7.70 per share (2012: \$7.25) or a total value of \$799,867,053 (2012: \$753,121,576).

9. INDEPENDENT AUDITOR'S REPORT ON THE SUMMARY FINANCIAL STATEMENTS

To the beneficiaries of Tauranga Energy Consumer Trust

The accompanying summary consolidated financial statements shown above, which comprise the summary consolidated statement of financial position as at 31 March 2013 and the summary consolidated statements of comprehensive income, changes in equity and cash flows for the year then ended and notes are derived from the audited consolidated financial statements of Tauranga Energy Consumer Trust and its subsidiaries ("the group") for the year ended 31 March 2013.

We expressed an unmodified audit opinion on those financial statements in our report dated 18 June 2013. Those financial statements, and the summary financial statements, do not reflect the effects of events that occurred subsequent to the date of our report on those financial statements.

The summary financial statements do not contain all the disclosures required for full financial statements under generally accepted accounting practice in New Zealand. Reading the summary financial statements, therefore, is not a substitute for reading the audited financial statements of the group.

The trustees are responsible for the preparation of a summary of the audited consolidated financial statements, in accordance with FRS-43 Summary Financial Statements.

Our responsibility is to express an opinion on the summary consolidated financial statements based on our procedures, which were conducted in accordance with International Standards on Auditing (New Zealand) (ISA (NZ)) 810 Engagements to Report on Summary Financial Statements.

Partners and employees of our firm may also deal with the group on normal terms within the ordinary course of trading activities of the business of the group as TrustPower consumers. This matter has not impaired our independence as auditor of the group. The firm has no other relationship with, or interest in, the group.
