TRUST GOVERNANCE

TECT and its subsidiary TECT Charitable Trust operate under Deeds of Trust respectively dated 21 December 1993 and 27 March 2002. Provisions of the Electricity Amendment Act 2001 also impact upon Trust Governance.

TECT is governed by six Trustees who are elected by Consumers for 4-year terms. The terms of appointment of Trustees are staggered so that three Trustees retire every two years. The current Trustees are Bill Holland (Chair), Bruce Cronin (Deputy Chair), Ken Collings, Ron Scott, Paul Tustin and Pete Blackwell. Trustees are responsible for managing TECT's assets for the benefit of qualifying Consumers. Trustee conduct is governed by a Code of Practice which is published on TECT's website.

CHAIRPERSON'S REPORT

Dear Consumers

I am pleased to report on another productive year for TECT.

Having established our own fully staffed office in 2014, this is the second annual report under the new management approach. I am pleased to report that the new approach has been very successful and has allowed the organisation to continue to grow its activities in the Western Bay of Plenty community. In his report our General Manager, Wayne Werder, provides more details of the activities for the year, but I would like to highlight some of the key milestones.

Diversified Investments

The sell down of a portion of Trustpower shares in 2015 provided the Trust with a level of diversification. After an extensive decision making process the proceeds from the sale have been reinvested into a Diversified Portfolio. Fidato Ltd, led by Ed Schuck have ably assisted the Trust with its investment strategy.

Trustpower

TECT's major investment remains a 26.8% shareholding in Trustpower. TECT once again received a healthy dividend equating to 42c per share. The operating environment that Trustpower competes in continues to be extremely competitive and the fall in Trustpower's share value across the year is evidence of this. At the time of writing Trustees continue to assess the proposal to demerge Trustpower's wind business.

Increased Consumer Cheques

An increase from the previous year was agreed taking the total allocation for distribution to \$30.9m. Trustees agreed to include additional payments for Consumers who also have their gas and internet services with Trustpower and this was received favourably by the majority of Consumers.

Improved Grant Making

It was pleasing once again to be able to support so many worthy organisations

and causes throughout the year.

Trustees approved 161 grants which is the most ever in TECT's history. I am continually amazed at the work that these community groups do in the community, and the many volunteer hours that are contributed. We are truly blessed to have these groups in our community helping make our region a great place to live, work and play.

Community Hub

The Community Hub project continued to evolve and the ability to work alongside the Historic Village has created some very exciting opportunities. We are absolutely convinced that the Hub will lead to even greater collaboration, and a more productive environment for the community organisations.

Significant Projects

The progress on the new university campus in Durham Street moved closer to reality. The funders, through the Tauranga Tertiary Campus Charitable Trust continued to work closely with the University of Waikato to ensure this facility will be of significant benefit to the wider Tauranga community.

Trustees

The biennial elections will take place this year and at the time of writing 11 candidates are standing for the three spots available. Once again this is an indication of the strong interest in TECT's

activities. Long serving trustees Bruce Cronin and Ken Collings both chose not to re-stand. Bruce and Ken have contributed to TECT's affairs over an extended period and we thank them for their input and wise counsel over a number of years.

I am very grateful to my co-Trustees for the amount of time they have spent in ensuring that all of these changes have been carried out in an orderly fashion. The TECT Board and staff are in excellent heart and ready to continue on this journey of improvement which has been so successful so far.

GENERAL MANAGER'S REPORT

It is a pleasure to report on the conclusion of another financial year. The year ended March 2016 will be the second full year that the TECT office has been operational and I am pleased to report that the organisation is in good health.

A number of key decisions were made throughout the year that have significantly changed the way that TECT goes about its business. I am pleased to report that these changes have been implemented successfully and will ensure that TECT continues to add value to its Consumers and partners.

Governance & Management

The goal of any organisation like TECT should be to operate in the most efficient and effective manner possible. As a management team of only three we are proud that we have been able to operate in a manner that supports this goal. As such I would like to thank TECT's staff, Paula Hudson and Jeanette Voss, for their commitment throughout the year, particularly with the increased workload which has been embraced as an opportunity not an issue. We are also supported by a number of advisors who continue to provide the specialist support when required, and I would like to acknowledge their contribution across the year.

The Trustees are charged with providing the governance and policy direction for the organisation. TECT operates with only six Trustees and as such it requires the full contribution of all for the organisation to function effectively. I wish to thank the Trustees for their support, guidance and wisdom throughout the year. This year we see the retirement of two long serving Trustees, Bruce Cronin, and Ken Collings. I would personally like to thank both Ken and Bruce for the support during my first two years with TECT and wish them all the best for their future endeavours.

Finance & Investment

Key financial results for the year are as follows:

- Group profit was \$146.4m, compared to \$42.5m in 2014/2015. This is largely due to the gain on sale of the 20 million Trustpower shares sold during the year which have previously been recorded at fair value. On sale of the shares, the cumulative gain previously recognised was required to be reclassified to profit or loss. This has limited impact on the equity position.
- Group expenses (before tax) were \$1.5m compared to \$2.5m in the previous year.

- Group equity decreased by \$26.5m to \$764m, largely as a result of the decrease in the Trustpower share price from the previous year.

Trustpower

In December 2015 Trustpower made a market announcement signalling that it was considering separating into two New Zealand listed companies; Trustpower Core, a largely New Zealand based hydro-electricity generator and retailer, and NewCo, a company focused on operating and developing Australasian wind assets. As a result TECT has conducted in depth due diligence on the proposal with the assistance of specialist advisors. This due diligence continues at the time of writing. TECT consulted with its Consumers re the demerger and the changes to the Trust Deed that would be required, and the feedback that was received was overwhelmingly supportive.

In the year under review, TECT received dividends from Trustpower of \$35.2m or 42c per share. The share price of Trustpower decreased from \$7.95 per share in the previous year to \$7.66 per share at 31 March 2016, which contributed to the overall reduction in total group equity.

Diversified Portfolio

In May 2015, in the interests of diversifying its investment portfolio, TECT sold 20 million of its shares in Trustpower. The shares were sold at a price of \$7.74 per share, totalling gross proceeds of \$154,800,000. TECT's current shareholding is 26.8 per cent of shares in the Company which ensures TECT retains the same degree of influence in the Company. Following the sell down, TECT Trustees committed to reinvest the \$154M into a diversified portfolio, and engaged Fidato Ltd to assist with the process of confirming an investment strategy to allow funds to be invested within an agreed framework.

Distributions & Grantmaking

TECT's primary distribution scheme remains its annual cheque to Consumers. In 2015 TECT introduced a new calculation for the cheques which saw further benefits for those Consumers with gas and internet services with Trustpower. In 2015 \$30.9m was allocated to be distributed tax free directly to eligible Consumers. The minimum amount distributed was \$435. Trustees have resolved to further increase the minimum amount to be distributed in November this year, to \$440 per eligible Consumer.

In the reporting year TECT made grants to 161 organisations, the most ever in one financial year in the history of TECT. In total \$9.3m was allocated to Community Organisations. These organisations are the backbone of the not-for-profit sector and the breadth and depth of their contribution to the wider Western Bay of Plenty continues to amaze. I encourage you to read further into this report to gain an appreciation of the extraordinary breadth of TECT's support for our Community Organisations.

The foundation laid over many years has provided the platform by which TECT can continue to benefit its Consumers and Community Organisations. In the 22 years of TECT's existence, \$306m has now been paid directly to Consumers and \$93m has been paid to Community Organisations, a significant contribution indeed. Looking ahead, we will continue to work hard to ensure that our Consumers can live and be engaged in a vibrant and enriching community.

CONSUMER CHEQUE DISTRIBUTION

TECT's primary distribution scheme is to Consumers by way of cheques. The cheque distribution is of significant benefit to Consumers and provides a huge cash injection into the local economy. To be eligible for the TECT cheque, you must be a Trustpower customer in TECT's District and have an active Trustpower power account continuously from 1 April to 30 September.



In November 2015, TECT distributed \$30,900,000 to eligible Consumers. Each Consumer received a fixed amount of \$435 plus a small variable amount based on their total spend with Trustpower over the six month qualifying period. 2015 saw the introduction of bonus payments for Consumers who also have internet and gas accounts with Trustpower.

The 2016 distribution will see eligible Consumers receive a fixed amount of \$440, plus a variable amount based on their total spend for the qualifying period. Further payments for Consumers with internet and gas account remain the same as 2015, and cheques will be mailed out in November.

NOTES TO THE SUMMARISED CONSOLIDATED FINANCIAL STATEMENTS

FOR THE YEAR ENDED 31 MARCH 2016

1. REPORTING ENTITY

These are the Summarised Financial Statements for the TECT Group comprising Tauranga Energy Consumer Trust ("TECT"), TECT Charitable Trust, TECT Holdings Limited and TECT Property Limited.

The Tauranga Energy Consumer Trust was established under a Trust Deed on 21 December 1993 as a consequence of the Tauranga Electric Power Board's Establishment Plan. TECT is a Consumer Trust, the income and capital of which are to be used to provide benefits to Consumers who are Trustpower customers in the area defined in the Trust Deed (being the area supplied by the Tauranga Electric Power Board as at 21 December 1993 subsequently amended to include the Tauranga district area previously supplied by Tauranga Electricity Limited).

TECT is not a Charitable Trust and accordingly may not continue for more than 80 years. On the winding up of the Trust the assets of the Trust, which remain, will be distributed for the benefit of Consumers.

At 31 March 2016 TECT Group held 83,878,838 shares, representing 26.8% in the capital of Trustpower Limited. On 22 April 2015 TECT Group sold 20 million shares, reducing its shareholding from 103,878,838 to 83,878,838 shares or 26.8% in the capital of Trustpower Limited.

2. BASIS OF PREPARATION

The summary financial statements are prepared in accordance with FRS 43 Summary Financial Statements. The full financial statements have been prepared in accordance with New Zealand

Generally Accepted Accounting Practice (NZ GAAP), as applicable for profit-oriented entities. The Trust has made an explicit and unreserved statement of compliance with International Financial Reporting Standards (IFRS) in its full financial statements.

This summary is extracted from the full financial statements authorised for issue by the Trustees on 1 July 2016, for which an unmodified audit opinion has been given. This summary has also been examined by KPMG and a copy of their summary unmodified audit opinion is included in this report.

The summary financial statements are presented in New Zealand dollars and rounded to the nearest dollar.

The summary financial statements cannot be expected to provide as complete an understanding as provided by the full financial statements of the Trust. You can obtain a copy of the full financial statements free of charge from the TECT office at 525 Cameron Road, Tauranga 3141 or the Trust's website, www.tect.org.nz.

3. TAXATION

The tax benefit of \$260,965 relates to current group tax charges of \$9,524,899 less Total Dividend Imputation Tax Credits of \$9,785,864.

4. DEFERRED TAX

Deferred Tax shown in the Statement of Financial Position arises primarily from revaluation of financial instruments to fair value. The deferred tax liability arising in relation to the fair value movements in Trustpower shares includes allowance for imputation

credits likely to be attached to future dividends. The level of imputation credits attached to dividends may vary significantly from year to year. Accordingly the deferred tax calculation has been based on an average of the credits received during the last four years. The estimated level of imputation credits is reviewed at each reporting date.

5. IMPUTATION CREDITS

As TECT is not a company it does not have an Imputation Credit account. TECT Holdings Limited is registered as an Imputation Group. As at 31 March 2016 the Group had imputation credits available of \$62,765,569 (2015: \$52,931,787).

6. TRUSTPOWER INVESTMENT

TECT Group has the majority of its funds invested in Trustpower shares. The share price is subject to significant fluctuations; in the two months immediately following balance date the price varied between a low of \$7.65 and a high of \$8.00 compared to a market price of \$7.66 at balance date.

7. COMMITMENTS AND CONTINGENCIES

There were no commitments or contingencies at the end of the financial year (2015: Nil).

8. RELATED PARTY TRANSACTIONS

Mr Bill Holland is a Trustee of TECT and TECT Charitable Trust and is a Director on the Board of each of the TECT Group's subsidiary companies.

NOTES TO THE SUMMARISED CONSOLIDATED FINANCIAL STATEMENTS

Mr Holland is also a Partner in the law firm Holland Beckett. TECT has entered into an agreement to lease premises with Spoke Investments Limited from Holland Beckett at an annual cost of \$48,000 (excluding GST).

Mr Paul Tustin is a Trustee of TECT and TECT Charitable Trust and is a Director on the Board of each of the TECT Group's subsidiary companies. Mr Tustin is also a Partner in the law firm Cooney Lees Morgan. During the year TECT has engaged the firm to complete work of a minor nature.

Trustees are required to be Consumers as defined in TECT's Trust Deed and are therefore beneficiaries of TECT and accordingly are related parties. All transactions with related parties are undertaken in the normal course of business on normal commercial terms.

9. INDEPENDENT AUDITOR'S REPORT ON THE SUMMARY FINANCIAL STATEMENTS

The accompanying summary consolidated financial statements, which comprise the summary consolidated statement of financial position as at 31 March 2016 and the summary consolidated statements of comprehensive income, changes in trust equity and cash flows for the year then ended and notes, are derived from the audited consolidated financial statements of Tauranga Energy

Consumer Trust and its subsidiaries ("the group") for the year ended 31 March 2016. We expressed an unmodified audit opinion on those financial statements in our audit report dated 1 July 2016. Those financial statements, and the summary financial statements, do not reflect the effects of events that occurred subsequent to the date of our audit report on those financial statements.

The summary financial statements do not contain all the disclosures required for full financial statements under generally accepted accounting practice in New Zealand. Reading the summary financial statements, therefore, is not a substitute for reading the audited financial statements of the group.

This report is made solely to the beneficiaries as a body. Our audit work has been undertaken so that we might state to the trust's beneficiaries those matters we are required to state to them in the auditor's report and for no other purpose. To the fullest extent permitted by law, we do not accept or assume responsibility to anyone other than the trust's beneficiaries as a body, for our audit work, this report or any of the opinions we have formed.

The trustees are responsible for the preparation of a summary of the audited consolidated financial statements, in accordance with FRS-43 Summary Financial Statements.

Auditor's responsibility

Our responsibility is to express an opinion on the summary consolidated financial statements based on our

procedures, which were conducted in accordance with International Standards on Auditing (New Zealand) (ISA (NZ)) 810 Engagements to Report on Summary Financial Statements.

Other than in our capacity as auditor we have no relationship with, or interests in, the group.

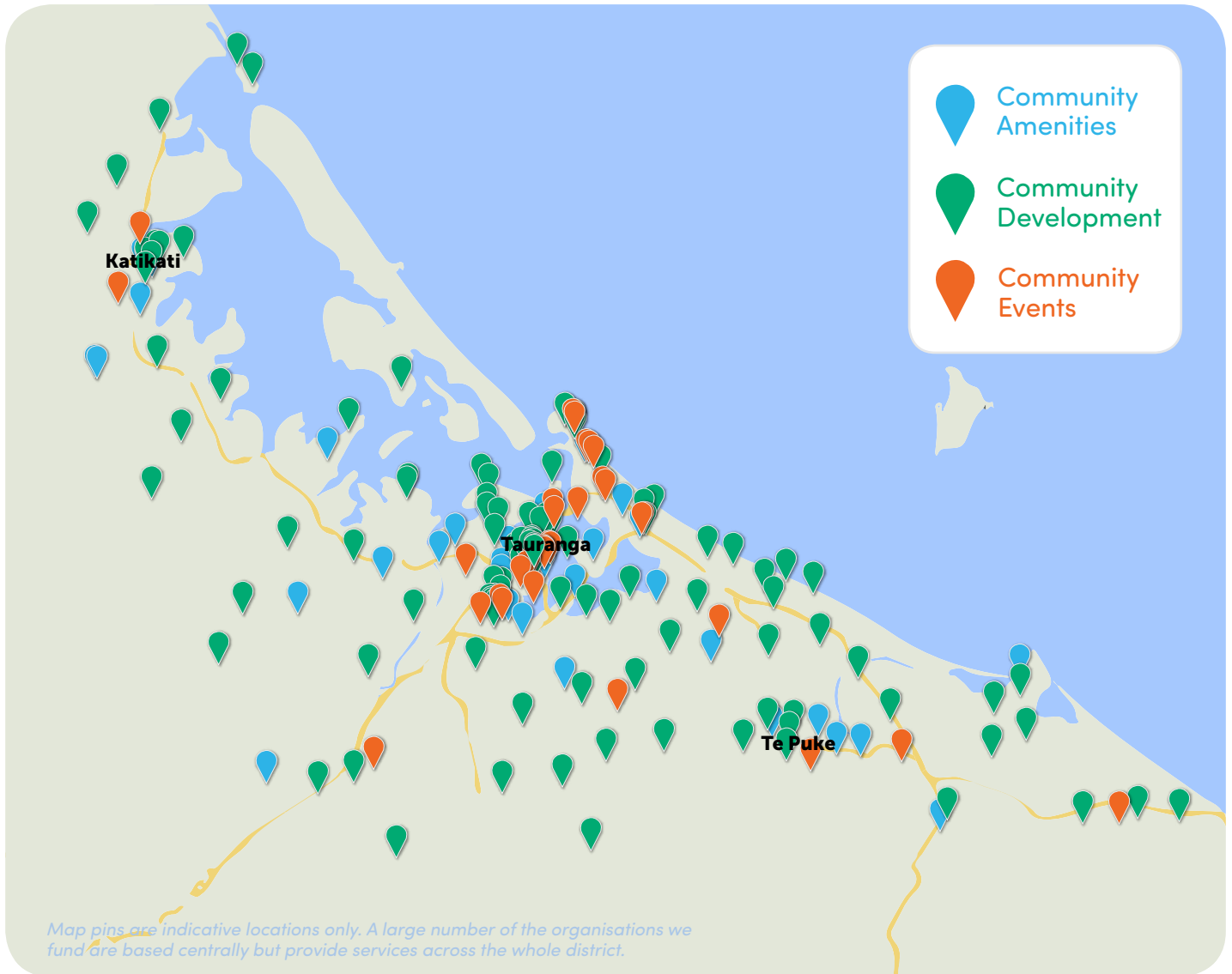
